## Illinois Remedial Course Requirements/Regulations

1. Our fee is \$90.00 due at time of enrollment. The class time is Saturday from 9:00am -1:00 pm.
2. To pass the remedial course, students must meet all of the following requirements:
  - a. complete all quizzes and tests
  - b. make positive contributions to class discussions
  - c. meet the minimum of 70% passing grade of the above
3. Illinois law requires a minimum of 4 hours of classroom instruction. Students who are late or leave early automatically fail the course.
4. The following items constitute **removal from the class** resulting in course failure and **may not enroll again.**
  - a) Students are not permitted to use electronic devices during the course (phones must be shut off or silenced). Smoking, eating or use of drugs/alcohol is not allowed in any part of the building, including the restroom, hallways, and outside of the building (water, soda, or coffee in a sealable bottle/thermos allowed).
  - b) Students are expected to conduct themselves in a mature and responsible manner at all times. Students are prohibited from using profanity, criticizing, causing a distraction or disturbance. **Students are prohibited from coming to class under the influence of ANY mind altering substance OR smelling like marijuana as the scent of marijuana can adversely affect other students and the instructor.**
  - c) Students are prohibited from possessing/using weapons.
  - d) Students are prohibited from causing any type of damage to the Balda Driving School building, parking lot, cars or possessions. Any student whose behavior causes other students or the instructor to feel unsafe will be dismissed from class and will not be permitted to enroll again.
5. Balda Driving School reserves the right to cancel any classroom session for such reasons as: inclement weather, instructor illness, etc.
6. As pursuant to Illinois Administrative Code Chapter 11 Section 1060.80C. The school will not refund any tuition or any part of the tuition if the school is capable and willing to perform its part of the contract.
7. A certificate will be sent to the Secretary of State upon satisfactory completion of the course.
