## **Instruction Sheet**TEEN BEHIND-THE-WHEEL ONLY (Driver Education 2)

If you have completed the classroom at the high school, you can do your Behind-the-Wheel training with Balda. We have two options for you to choose from:

**BASIC OPTION** #1\* - Six (6) hours of Behind-The-Wheel (BTW) instruction and six (6) hours of observation which meets the Illinois State requirement for Driver Education 2. Our fee is \$350.00 paid prior to the first lesson or use our easy-pay plan of two payments of \$175.00 paid prior to the first and third scheduled lessons.

**PRIVATE OPTION** #2\*\* - Eight (8) hours of driving with an instructor without another student in the car to observe. Our fee is \$450.00 paid prior to your first lesson or use our easy-pay plan of two payments of \$225.00 paid prior to your first and third scheduled lessons.

The following **4 forms** will need to be completed and returned to us before we can schedule your Behind-the-Wheel (BTW) training. Contact the office for BTW lesson availability.
